mRNA COVID-19 VACCINES, THE NEW TOBACCO - A SILENT KILLER?

NOVEMBER 22, 2022

- 1. For years, Big Tobacco denied harm from smoking, citing numerous “scientific” studies it had funded and conducted – the findings of these studies were false.**
- 2. Now, Big Pharma companies Pfizer and Moderna, have been instructed by the US FDA to conduct internal clinical studies into possible links between their mRNA Covid-19 vaccines and Myocarditis.**
- 3. Myocarditis is only one of many serious adverse reactions linked to these vaccines, such as Pericarditis, cardiac arrest, coagulation disorders (thrombosis), acute kidney and liver injury, Bells Palsy, optic neuritis, Guillain-Barre syndrome, encephalitis/encephalopathy, Ischemic stroke and seizures.**

In letters dated January 31, 2022, the US Food and Drug Administration (FDA) wrote to these pharmaceutical companies noting that it has determined that an analysis of spontaneous postmarketing adverse events reported under section 505(k)(1) of the Federal Food, Drug, and Cosmetic Act (FDCA) will not be sufficient to assess known serious risks of myocarditis and pericarditis, and identify an unexpected serious risk of subclinical myocarditis. Therefore, based on appropriate scientific data, the FDA has determined that each manufacturer is required to conduct studies to evaluate the occurrence of myocarditis and pericarditis following administration of its Covid-19 vaccine and boosters.

On November 12, 2022, NBC News confirmed that both Pfizer and Moderna are commencing studies into the incidence of Myocarditis following vaccination of their Covid-19 products.

PCS questions the impartiality of Pfizer and Moderna to conduct these studies, particularly in view of the previous history of selective data gathering and refusal to make public all original Covid-19 vaccine trial data. In January 2022, Bloomberg Law reported that a group of medical researchers sued for the release of many thousands of documents, including all clinical trial data, related to the licensing of the Pfizer BioTech Covid-19 vaccine. The claim was opposed on the basis that this data should not be released for 75 years. So much for the FDA promises of full vaccine transparently made in November 2020.

The Pharmaceutical Violation Tracker records that Pfizer has more breaches of law than any other pharmaceutical company. Since 2000, Pfizer has been found guilty of 91 breaches, with total fines exceeding US\$10 billion. These breaches include kickbacks and bribery, safety violations, false claims, corrupt practices, environmental violations, consumer protection violations, environmental violations, employment discrimination and workplace safety violations. The most recent series of violations resulted in the largest fine ever received by a pharmaceutical company, totalling US\$2.3 billion. Pfizer was found guilty of a felony, for misbranding with the intent to defraud, illegal promotion, false claims and payment of illegal kickbacks. Mr Tony West, the US Assistant Attorney

General dealing with this recent case stated; “this settlement represents another example of what penalties will be faced when a pharmaceutical company puts profits ahead of patient welfare.

Pfizer could reasonably be regarded as a “habitual offender”, and this is not a company PCS could seriously believe will conduct impartial and honest studies into the assessment of its extremely profitable Covid-19 vaccine’s links to Myocarditis. In February 2022, the Guardian News reported Pfizer made US\$37 billion in 2021, just from its Covid-19 vaccines. 2021 revenues doubled the 2020 revenues.

In relation to the Pfizer mRNA Covid-19 vaccine, this company has to date misled by omission details of vaccine efficacy, particularly its ability to stop transmission and infection, misled about the extent of serious adverse reactions and misled about its actual risk reduction, publically indicating 95% while seeking approval, when in fact, the absolute risk reduction was 0.84% (later reported by The Lancet in 2021, that for every 119 individuals vaccinated, only one would be protected from Covid infection).

Moderna uses the same mRNA technology as Pfizer for its Covid-19 vaccine, which therefore has similar failings in efficacy and a similar profile of serious adverse reactions to the Pfizer product. In May 2020, the STAT Website reported that vaccine experts have accused Moderna of failing to produce data for this Covid-19 vaccine that is critical for independent assessment. Moderna’s response was to blitz the media with marketing words, only revealing selective information or data.

In 2020, the Wall Street Journal and Fortune both reported that until its mRNA Covid-19 vaccine, Moderna had not managed to achieve approval for a single drug or vaccine. Accordingly, Pharmaceutical Violation Tracker records no Moderna breaches. In fact, until its mRNA Covid-19 vaccine, no company using the same experimental approach had managed to achieve approval. In the 9 years of its existence, Moderna has developed more than 20 experimental drugs and vaccines for cancer, infectious diseases and other conditions, but none are close to being commercially available to patients. Given this, how could the efficacy and safety of its mRNA Covid-19 vaccine for a disease only discovered in late 2019, be developed and approved in a few months?

According to the January 2022 letter, the FDA appears to have granted Pfizer and Moderna up to two years to conduct these new trials to determine if the mounting evidence of just a single cardiac injury is truly related to their mRNA Covid-19 vaccines. However, the many other possible serious adverse reactions do not appear to have been mentioned for study. One can only sympathise with the families that may be faced with loved ones suffering from diminished health or potentially losing their lives as a result of the mRNA Covid-19 vaccines, while Big Pharma dithers, manipulates the new data and continues to reap massive profits.

PCS once again calls on the Australian Government to immediately suspend Covid-19 vaccination programs for those low risk age groups, and launch and fully fund an independent investigation into the safety and efficacy of the Covid-19 vaccines, conducted in Australia by reputable and qualified scientists that have no ties or allegiances to any pharmaceutical companies.
